At a Regular Meeting of the Town Board of the Town of Hounsfield, held at the Town offices, 18774 County Route 66, Salt Point Road, Watertown, New York, on October 9, 2024, there were:

WHEREAS, the Town Board of the Town of Hounsfield has agreed to create Water Service Area No. 8 and selection of Alternative 2 in order to provide a water supply and distribution system to Town residents; and

WHEREAS, a question has been raised regarding the rights and responsibilities of the Town and property owners relating to laterals following construction; and

WHEREAS, the Town Board would like to remove any confusion related to such rights and responsibilities by adopting a Clarifying Order regarding Water Service Area No. 8.

FOUND, ORDERED, AND DETERMINED that a public hearing regarding this matter shall be held on the 13 day of November 2024 at 7:00 PM at the Town Offices located at 18774 County Route 66, Salt Point Road, Watertown, New York 13601 to hear all persons interested; and it is further


FOUND, ORDERED, AND DETERMINED that the Town Clerk shall cause a copy of this Order to be published at least once in the official newspaper for the Town of Hounsfield not less than ten (10) nor more than twenty (20) days before the date set for the hearing, and shall cause a copy hereof to be posted on the sign board of the Town of Hounsfield maintained pursuant to the provisions of the Town Law, not less than ten (10) nor more than twenty (20) days before the date designated for the hearing and shall be uploaded on the Town of Hounsfield’s website; and it is further

FOUND, ORDERED, AND DETERMINED that the Town Clerk shall cause a copy of the aforementioned Clarifying Order (included herewith as **Exhibit “A”**) to be published at least once in the official newspaper for the Town of Hounsfield not less than ten (10) nor more than twenty (20) days before the date set for the hearing, and shall cause a copy hereof to be posted on the sign board of the Town of Hounsfield maintained pursuant to the provisions of the Town Law, not less than ten (10) nor more than twenty (20) days before the date designated for the hearing and shall be uploaded on the Town of Hounsfield’s website.
